



Market Ambassador

Columbia Farmers Market has been a staple of Columbia's local food economy since 1980. The mission of Columbia Farmers Market is "a space for our vibrant community of growers, producers, and makers by supporting, educating, and expanding sustainable mid-Missouri agriculture." Our market is a "producer-only" market and one of the premier locations for locally grown food in mid-Missouri. Markets are held every Saturday morning year-round, and a Wednesday Market is held early summer - early fall. A small staff and a volunteer Board of Directors run Columbia Farmers Market. Supervisor: Executive Director, Assistant Manager

Hours/Week: Part-time, 5-12 hrs./wk. This is a year-round, part-time position. Hours may range during seasons and depending upon experience.

Days and Hours: Summer: Saturdays from 6:30 a.m. to 12:30 p.m.; Winter: Saturdays from 7:30 a.m. to 12:30 p.m. Additional hours may include Wednesday, 3 p.m. to 7:30 p.m. (early summer through early fall), monthly staff training, farm visits, special market events, and community events/tables opportunities.

Job Description: Market Ambassadors will proactively approach and greet customers, give market tours, conduct customer surveys, conduct weekly product sampling, answer customer questions, assist SNAP customers using their tokens, and provide any other needed assistance. Ambassadors must be able to self-manage. Knowledge of CFM membership, organization, and market values is necessary; one must be able to communicate that information effectively and accurately to customers. The person in this role will be able to develop meaningful relationships with people from many different backgrounds and should be able to effectively communicate their passion for local food systems and farmers markets therein.

Qualifications

- Lift 40 lbs. and able to be on feet for 8+ hours.
- Must be available to work Saturdays from 6:30 am – 1:00 pm and attend monthly trainings. Additional hours may be available.
- Self-motivated, incredibly outgoing, and enjoys working with the public
- Ability to work in an often fast-paced environment
- Comfort adjusting to variable work conditions (i.e., all-weather types) and changing priorities
- Strong interpersonal and communication skills
- Adept at establishing and maintaining strong and respectful professional relationships and a pleasant demeanor
